APPLICATION FORM FOR INDIVIDUAL MEMBERSHIP IN AIYS

Membership in AIYS includes *Yemen Update*, the annual bulletin, and occasional English-language publications. Members may also stay in the AIYS hostel when in Yemen.

Annual membership fees are \$10 for students and retired persons, \$25 for individuals, and \$250 for institutions and corporations (for institutional and corporate membership applications contact the AIYS office). Applications for student membership must show evidence of student status (e.g., a copy of student I.D.). Add \$10 to the cost of membership if mail is received outside the U.S. Multiple-year memberships are accepted. AIYS' bank will negotiate foreign-origin US\$ checks only in amounts larger than \$200; the check must show both an ABA routing number and a bank transit number.
